RULES

1. Entry date: (To be set) at the Extension Office. State classes to be entered. \$1.50 for four entries or less; \$2.00 for more than four entries per exhibitor. (Change in fee)
 2. Entries are limited to Warren county residents or members of the Warren County Genealogical Society. (Allows our club to show)
 3. All entries should be accompanied by information to show their genealogical connection to the exhibitor.
 4. Exhibitors are limited to one entry per class.
 5. Exhibits which have won premiums in previous years may not be entered again in the same class. (New rule)
 6. Diligence will be used to insure the safety of articles after their arrival and placement, but in no case will the management be responsible for any loss or damage that may occur.
 7. Entries are to be in place no later than noon on Saturday, July 28. Entries will be accepted from 9:00 am to noon only. Judging at 1:00.
 8. Exhibits are to be picked up by 10:30 am on Thursday, August 2. Superintendents will not be responsible for anything left after that time. (Fair board will set time building to open on Thurs.)
 9. Superintendents reserve the right to reclassify exhibits if nec.
 10. Senior division is open to all ages. Junior division is open to those 16 and younger. (Allows jrs to show in sr. div. if they want)
