Board then proceeded to canvass the votes cast at the general election held on the 6th of Nov, 1888, and found the results as follows:

For the office of the Clerk of Court of Warren county, Iowa there were 4064 votes cast, of which John H. Derrough received 2352 and Clyde Reed 1712 votes.

For the office of County Attorney of Warren county, Iowa there were 3986 votes cast of which W F Powers received 2271 and John S. McKinney 1715 votes.

For Member of Board of Supervisors of Warren county, Iowa, W J Cochran received 2310 and T D Simons 1748.

The Board also declared the following named kpersons to be duly elected justices of the peace of the various townships:
