The Warren County Genealogical Society met September 16, 1996, at the Indianola Public Library. Twenty-two members, two guests and our speaker were present.

President Ev Brightman began the business meeting at 7:00 PM. Those present introduced themselves and told about their favorite or most remembered saying of an ancestor.

The minutes were approved as read. The treasurer reported a balance of \$2359.88 in the checking account and \$5494.01 in the Super Saver account.

Corresponding secretary Thelma Pehrson reported that we now have the Clarke County Cemetery book, Volume 1, for the library and that the queries are caught up. She also reported for Vicki Montgomery that Warren County marriages are done for 1900. Thelma has 1901 ready for the computer and is working on 1902. Thelma has indexed the Memorial and Biographical Record of Iowa for Warren County people and it is ready to be typed. She will soon be finished with extracting genealogical information from wills. She is now working on 1904 newspapers at the Historical Society Library while JoAnn Harvey is working on 1903. Ev suggested that the marriages might be put into books.

Ev thanked the members of the society that had helped with the Warren County Fair and reported that the executive board had decided that Donna Crow will review the popularity of categories and update their definitions. The number of categories must remain the same but titles may be changed. Ev noted that the trip to the Historical Society Library in Des Moines had been a success. Six members went on the van and three came on their own later.

Under new business she reported that a Beginner's Workshop will be on October 19 in the fellowship room of Trinity Presbyterian Church. On October 26th there will be two events. The Lucas County Genealogical Society will hold a day-long workshop and the IGS will hold a slumber party at their library in Des Moines.

Ruth Hall announced that Jack Jenkins will speak about oral histories at the November meeting and asked for suggestions for a program for the October meeting.

Ev said that Ruth Iverson is no longer coordinating the sale of the Warren County Atlases. They will be stored at the Municipal Building and a volunteer is needed to keep a list of what is sold.

There was a motion from Louise Pilmer that the meeting be adjourned, the second was by Jean Johnson. Meeting was adjourned at 7:20 PM.

Ev introduced the speaker, Dr. Tom Morain, the administrator of the Iowa State Historical Society, who spoke on "Growing Up in Iowa".

The Warren County Genealogical Society met October 21, 1996, at the Indianola Public Library. The meeting was called to order by President Ev Brightman at 7:00 PM. There were twenty-two people present including two guests and one new member. As roll call each of us told about the ancestor we would most like to talk to and the question we would most like to ask of them.

The minutes were read and approved as read. The treasurer's report was approved. Jane reported a balance, as of October 15, of \$2367.70 in the checking account and \$5502.95 in the Super Saver Account. During the past month there was income of \$53.50 from the sale of materials and from a donation and disbursements of \$45.68 for newsletter mailing and workshop expense.

Ev reported that there were 6 people at the beginner's workshop which brings to 23 the number that have attended the workshops. Three of the people joined the WCGS: Carol Van Aernam, Betty Casper, and Jeanne McKeever. Ev also reported that Jane Godwin will be keeping records on the Warren County Atlases. Ev will attend a workshop sponsored by the Lucas County Genealogical Society this Saturday. She also reported that in the recent board meeting there had been discussion of the use of money in the treasury and it was decided to wait until we know the cost of the updating of the cemetery book before we plan other expenditures.

Under new business Ev said that Donna Crow and Willa Jean Grissom will serve as the nominating committee and will have a slate of officers for the November meeting which is the annual meeting. Since Jane will miss that meeting she asked that someone be in charge of taking membership dues for 1997 that become payable then. John Kern offered to do this. Ev thanked Thelma Pehrson for taking care of reserving the library for our future meetings.

Ev then passed out sign-up sheets for committee service and asked us to complete a questionnaire about out personal and group expectations for the coming year. She will be making a program book for the 1997 year. The meeting adjourned at 7:45 and the group viewed the video "Island of Hope-Island of Tears" which is the Ellis Island Immigration Museum Film.

Greetings,

October 26 I attended our Area 4 Genealogical Society's meeting held at the John L. Lewis Museum in Lucas, Iowa, and sponsored by the Lucas County Genealogical Society. I found it to be a very enjoyable day with many ideas shared and generated among participants. Lucas, Warren, Clarke, Wayne and Mahaska counties were represented. Each society displayed materials for sale (one Birthbook and an exchange offer). I also displayed our county fair book and exhibits as well.

Ron Roberts, a professor at the University of Northern Iowa and author of "Ordinary Ghosts and Everyday People in an Iowa Mining Town" and a biography of John L. Lewis, presented in the afternoon. He is trying to preserve a history of the Iowa coal mines and their influence on the migration patterns and lives of early Iowans. On a personal note-my great uncle, Charles Richard Hogg, from Bletzburg, Sweden, was included in the presentation of records depicting causes of death in the Lucas Mining population. Professor

Roberts previously had no information identifying specific areas in Sweden from which the Swedish miners working (and dying) in the Lucas/Cleveland mines came.

Hopefully the Area 4 meeting will become an annual event.

Thanks to all of you for your participation, feedback and suggestions for plans for the coming year. I <u>will</u> be calling to complete the goal of having all committee slots filled and each member involved.

FROM OTHER NEWSLETTERS

<u>Butler Branches</u>: Butler County G.S. held an all day workshop on "Immigration". It was co-sponsored by the Clarksville Library.

<u>Des Moines County</u> G.S. arranged for instructional sessions on using the Internet for genealogical research with the help of their extension office. Twenty members participated.

<u>Clarke County Roots & Branches</u>: Volume II of <u>Clarke County</u>, <u>Iowa Cemeteries</u> should be out this spring. It will contain all the cemeteries except Maple Hill which was Volume I. (WCGS has Volume I in their area of the public library.)

The <u>Dubuque County-Key City GS</u> has a member who offers free genealogical help to the public at the local library on Tuesday evenings.

Guthrie County GS: Ancestors who emigrated overland to the West may be part of a data base formed by the Oregon-California Trails Association(OCTA). Their project, called the Census of Overland Emigrant Documents(COED), surveyed emigrant diaries, reminiscences, and letters. As of January 1996, 2,078 documents have been surveyed by COED and 55,000 names recorded. To request a form for a surname search mail a SASE to: Census of Overland Emigrant Documents, Oregon-California Trails Association, Box 1019, Independence, MO 64051-0519. Fees are \$10 per surname. The information they provide will usually be the name of the document containing the name and where it can be located.

<u>Central Iowa GS</u> of Marshalltown, sells tickets for \$7 to a candlelight tour of a local cemetery on a late September Saturday evening. Tours leave every 7 minutes with 17 people in each group. Twenty-two local actors portray individuals who played a part in Marshalltown's history.

Lucas County Notes and Shakin the Family Tree! Five members went on Vancestoring II and plans are being made for next year. (They talked to our group about their trips that stop at several libraries over a several day trip.) Also, they have designed two logos with the name of the club that they have put on transfers that can be used on sweatshirts, cloth bags, etc.
